# Interview with Mr. Naci Can

Calık Energy Swiss AG
Deputy CEO for International Funding & Investments

#### Mr. Can tell us a little bit about your background.

I am the Deputy CEO for International Funding & Investments at Çalık Enerji, a Board Member of Calik Enerji Swiss AG ("Calik Swiss") and Jasper Trading in Poland, and an Executive Manager of Calik Enerji Japan. I lead teams responsible for structuring and arranging financing for EPC-F projects, mergers & acquisitions, assessing feasibility, ensuring bankable development, and securing project financing for renewable energy and technology investments. In addition, I am responsible for optimizing working capital and guarantee facilities for EPC projects through various international funding sources and partnerships. Before joining Çalık Enerji three years ago, I was Senior Commercial Finance Staff Manager at GE Gas Power for the EMEA region. I facilitated financing to over 10 GW of high-efficiency gasfired power plants and renewable energy projects. Before GE, I held senior finance positions in New York and Istanbul, including at BBVA-Garanti, UBS Investment Bank, and Moody's Investors Service. I have a triple Bachelor of Science in Business Administration, Economics, and History & Policy from Carnegie Mellon University. I am deeply committed to creating value, positively impacting the energy transition, and delivering sustainable solutions for our clients, partners, and stakeholders.

### What is your impression of Switzerland and the Swiss market so far?

Our perspective on Switzerland and the Swiss market is overwhelmingly optimistic, particularly in the energy and infrastructure sectors. Switzerland's industry focus and strengths align well with our business objectives. It is a stable jurisdiction and a key market for attracting new talent. Overall, it provides a solid foundation for companies like Calik Swiss, offering ample opportunities for investment and growth in energy infrastructure and energy transformation project developments. The robust network of Swiss industrial partners and suppliers in the energy sector and the development of customized services and innovative financial products present significant opportunities for securing large-scale projects in the global energy infrastructure sector.

### Name us three extraordinary things about Calik Enerji Swiss AG.

Regional Expertise: Calik Swiss stands out with its global presence in diversified geographies, targeting various regions, including the Middle East, Central Asia, Africa, and Eastern Europe. This allows us to capitalize on the diverse market opportunities in rapidly developing and emerging economies and established markets. Founded seven years ago, we have gained experience in a broader geographic region and are poised to capitalize on this. Our ability to connect Swiss exporters with third countries, particularly SMEs, further set us apart.

Connecting Swiss exporters with third countries: Implementing large energy infrastructure projects entails global sourcing activities, including sourcing from Switzerland. Calik Swiss has managed this process effectively and is looking to expand its efforts to help Swiss exporters, particularly SMEs, access these infrastructure projects by giving them access to markets that would be difficult for them to access on their own.

New energy investments: Calik Swiss actively monitors the recent developments in energy transition, including new energy technologies, focusing on green hydrogen and ammonia. This strategic focus is driven by the need to follow global market trends and utilize these innovative solutions in our current and future projects.

### What is the biggest challenge Calik Enerji Swiss AG is facing in Türkiye / Switzerland?

Establishing brand recognition in Switzerland is challenging, but it is crucial for gaining a foothold in the market. One of the specific challenges we face is reaching small suppliers and SMEs in Switzerland. Our sourcing requirements often lead to difficulties, particularly with long delivery times. Access to these smaller suppliers can impact our ability to efficiently source the materials and services we need for our projects. Therefore, the support we can receive from the Chamber is becoming increasingly important in addition to working with Team Switzerland to help us navigate the local landscape and overcome these obstacles to build more concrete connections with suppliers.

#### What are the gains?

Strategic partnerships with local companies, export credit agencies, and international organizations are crucial to leveraging expertise, accessing resources, and ensuring the efficiency and market relevance of our projects. These partnerships not only foster the growth of Switzerland's utility-scale renewable energy supply chain but also create a win-win situation for all parties. Working together can accelerate the global energy transition and contribute to a more sustainable future. Calik Swiss also aims to increase its brand value and awareness regionally and internationally. 





The opening speeches were delivered by Mr. Arpat Senocak, President of the Swiss Chamber of Commerce in Türkiye and H.E. Mr. Guillaume Scheurer ,Ambassador of Switzerland to Türkiye.

The panel, moderated by Ayşe Güçlü Onur from Egon Zehnder Türkiye, featured Erik Swars from SFUVET, Leszek Wącirz from Nestlé Türkiye, and Dr. Aybike Mergen from Özyeğin University, and addressed in details the impact of artificial intelligence, technology and changing business dynamics on leadership.


